Sir,

We are pleased to inform you that the 29<sup>th</sup> Emergent Academic Council Meeting of this University held on November 07, 2023 had, vide Resolution No:EAC:29:2023:5:7(i):Section:A:Item:XVII resolved to renew the Provisional Affiliation of your college for the B. A. (Hons) in English, Garo, Political Science, History, Economics, Education, B.A. Electives in Alt. English/Garo MIL, Garo Elective and EVS Courses for a further period of 3 (three) years with effect from January 2023.

Kindly note that in view of the conditions the Inspection Team has stipulated the College to fulfill, **the Council** has also resolved to direct the College:

- 1. To appoint 2 (two) more Teachers in EVS in strict adherence to UGC/NEHU norms.
- 2. To automate the College library and have additional space in it.
- 3. To procure more book titles (both text and reference books) in all the seven (7) subjects as per University norms in respect of library facilities.
- 4. To subscribe to more research journals and periodicals.
- 5. To construct additional Washrooms in the top floor of the new building.
- 6. To encourage the faculty to fulfill the minimum UGC/University stipulated qualifications by clearing NET/SLET and joining in research work towards obtaining Ph.D.
- 7. To facilitate other higher studies/ participation in Refresher /Orientation courses as prescribed by the UGC form time to time.

The Academic Council also recommended that in view of the need for being NEP 2020 compliant, the college management must make all efforts to upgrade the College into a multi-faculty institution to facilitate introduction of multi disciplinary courses at its campus and has been envisaged in the New Education Policy (NEP-2020).

The office of the undersigned may duly be informed about the compliance status of the conditions mentioned here at above within three months from the date of receipt of this letter. The institute is required to apply for renewal of its Provisional Affiliation now granted six months prior to its expiry. As such, the renewal applications of institute may please be submitted to this office **by June/July 2025**.
