Qualitative analysis of Criterion 1

Williamnagar Government College, established in 2000 with temporary affiliation to the North-Eastern Hill University (NEHU) Shillong, Meghalaya since 2001 and follows the curriculum and syllabi of the courses offered and designed by the affiliating university. The institution offers UG program of Bachelor of Arts and from 2017 has started Honours in the disciplines of Economics, Education, English, Garo, History and Political Science. The college has been following the semester system since 2015 and adheres to the Academic calendar of the University. The Institution has a vision and mission. There are 30 sanctioned posts and 28 are filled with permanent faculty with 12 officials as support staff. The 02 faculty members are each in the Board of Studies of the Affiliating and other University of the State. The institution has prepared for the implementation of NEP-2020 from the current year as per the design evolved by the Affiliating University. The institution integrates crosscutting issues gender, environment and sustainability into the curriculum supported by the extension activities. The college has the Ong'telaigipa Environmental Club which conducts community outreach program. The college also has one unit each of NSS and NCC for both boys and girls. The field trips, workshops and seminars are organised for the students on vital themes. Feedback is taken from students, and teachers manually and the data collected is compiled, analysed and reported to the concerned department.

The College has a total enrolment of 1392 students. The Admission policy, eligibility criteria and profile of students is as per the norms of the State Government and the affiliating University. The reservation policy is strictly followed and the students come mostly from the ST category and disadvantaged students coming from low socio-economic background and first generation educational backgrounds. The student- teacher ratio is good but the use of ICT tools for teaching —learning process is meagre. The strength of full-time teachers against the sanctioned posts during the last five years has been good. There are 11 NET qualified teachers, 1 M. Phil teacher and 5 Ph. D teachers out of 28 only. Only 15 teachers are qualified as per the UGC norms and 13 are appointed as per the State Government norms. The College follows the scheme of 75: 25 as external and internal marks—given by NEHU for the conduct of examinations and Continuous Internal Assessment respectively. The Institution has constituted the Examination Committee consisting of faculty members from various departments to facilitate the examinations and CIAs. The pass percentage and performance of the students is encouraging. In order to improve the teaching skills of the teachers, they are encouraged to undergo faculty development programmes. The teachers engage students in group- discussions, questions and answers mechanism to some extend. The program outcomes and course specific outcomes need to be reflected on the website of the college and communicated to the students through various modes.

The institution has created Entrepreneur and Vocational cell in 2022 to organise the Skill Development Programs for the students and explore the possibilities of start-ups for them. The institution has organized some workshop on vital issues, health Programme and Entrepreneurship Programme in the last five years. During the assessment period the faculty has published five Research articles in the some UGC CARE listed journals. Three faculty members of the institution from the Department of Economics, English and Political Science have published 01 book and edited chapters in journal with ISBN during the last five years. The NCC and NSS wing of the college carries various extension activities which include Tree Plantation Drive, Water Conservation Awareness, Cleaning Drive, World Environment Day, Blood Donation, Puneet Sagar Abhiyan and Poshan Maah. The institution has adopted the 'Adopt-a-Lake' Community Outreach Programme, whereby the institution has adopted a lake called Memo Lake, maintained by the community of Bolkinggre village of East Garo Hills, Meghalaya. The outreach program is an initiative that encourages the preservation, maintenance and appreciation for natural resources of the district. The institution has got the recognition of the extension activities by winning the District Green Champion Award by the Mahatma Gandhi National Council of Rural Education (Swachh Campus) for the year 2021. The institution collaborated with the Nokma (villagehead) of Bolkinggre, East Garo Hills, Meghalaya on the 14th September 2022 stating that the lake has been adopted under Community Outreach Program of the College for a period of five years. The institution entered into an agreement with the Avenues, Shillong- a private venture- in the year 2017 and as per agreement the later has conducted 20 hours career readiness and soft skill training program in the College for the benefit of the students and paid an amount of Rs. 5,34,894/= from RUSA funds to the agency.

Qualitative analysis of Criterion 4

The institution has an area of 12.046 acres of land with a built up area of 7023.12 sq. mtrs. in an urban setting. At present, the institution has three old one storey buildings class rooms with 02 OHPs, Seminar hall, office, 5 staff quarters Library room, 01 CommonTeacher's Room, Examination cell, IQAC cell and some small office rooms and space for IGNOU study centre. All the rooms need renovation, however, a multi-storied building has been constructed with State Government funding and near completion but yet formally to be handed over to the institution. The Government of Meghalaya has sanctioned rupees twelve crores (12 crores), in the year 2020 for constructing the building including Boys' and Girls' Hostel. The drinking water, college bus and power backup facilities are available. The college library computer is installed with Koha using Integrated Library Management System (ILMS) and books computerised and automation is under process. It has a collection of 10916 books, reference books and some periodical journals, and magazines. Some e-resources are found but only one computer is available as a server. At present there is no reading room facility in the

library and automation of the library is yet to be done. The institution needs to equip the library with computers and the reading room facilities for the students. The two ICT enabled classrooms having LCD projectors are available for conducting multiple activities of the institution. The institution has a 13 desktops in office, library, administration, examination cell, Students Union Office and a few laptops. The CCTV cameras are installed for surveillance in the campus. The college needs to develop sports facilities, canteen, health care centre and proper development of the playground. The construction of boundry wall must be taken on top priority to ensure safety of the students.

Qualitative analysis of Criterion 5

The Students of the institution have benefited from government scholarships under the Post Matric Scholarship Scheme having predominantly ST students but the institution has to evolve a mechanism of awareness and guiding the deserved students to get benefitted by the scheme as a very less number of students have availed this facility. The college offered a some soft skills program to 200 students in 2017 as add on courses and some classes were arranged for competitive examinations and attended by some students. The career preparedness soft skill was conducted by Avenues, Shillong, with the financial aid from RUSA, Meghalaya, arranged for the B.A. Semester I and paid by the college. To address student grievances, the college has established a grievance redressal cell, Internal Compliance Cell, and Anti-Ragging Committee but all such committees need to be more active in their functioning. Some students graduating from the college pursue higher education and a few work in public and private sector. The students participate in extension services through NSS and NCC and also participate in cultural activities. The institution has a registered Alumni Association since 2021 but needs to contribute towards the development of the institution.

The College works in accordance with the vision and mission. The leadership and governance is decentralised and managed through various committees. The teachers are involved in decision making processes both in teaching and administrative activities and some teachers are provided financial support for attending conferences and workshops. The college has an Advisory Committee comprising of the important stakeholders from public and private society. The institution follows all the policies, service rules, procedures, promotion policies and regulations, welfare measures for both teaching and non-teaching staff are in accordance with the Meghalaya Service Rule 2019 and APRs. Being a government college all the funds flow from State Government. The financial auditing is done and utilizations are prepared regularly. The IQAC established in 2018 is participating in the academic issues of the college through regular meetings and workshops, reviews the teaching learning strategies and processes to ensure quality improvement in teaching learning.

The institution promotes gender equality for the students of the college and committees are constituted for the safety and security of the girl students. The committee against Sexual Harassment, Anti Ragging and women cell are in place for awareness and Gender Sensitization among the students but need to be more active in their respective responsibility. The students are encouraged to respect all cultures, regions, linguistic and socioeconomic diversities. The institution celebrates national and international comemorative days, events and festivals. The best practices implemented by the institution is 'Green campus and Tree plantation activities and participated under Ek Bharat Shrestha Bharat (EBSB) in online mode to celebrate the World Environment Day. The Ong'telaigipa Club—was constituted to encourage the students, faculties and non-teaching staff of the institution to become aware of the environmental issues and preserving the environment. The use of ICT was done during pandemic to impart knowledge and education and to make students competent and confident users who can use the knowledge and skills acquired to assist them in their daily life. A distinctive practice adopted by the college is through the "Adopt-a-Lake" Community Outreach Programme, whereby the Institution has adopted Memo Lake, maintained by the community of Bolkinggre, East Garo Hills District, Meghalaya. The Outreach programme is an initiative that encourages the preservation, maintenance and appreciation for natural recourses of the district.

- Organising more seminars and workshops for students and teachers
- To motivate students to attend classes regularly and to reduce dropout rate.
